







Humanitarian Networks and Partnerships Week 2024: Guide for the Private Sector

OVERVIEW

Humanitarian Networks and Partnerships Weeks (HNPW) is the largest annual gathering of humanitarian practitioners and experts from United Nations agencies and international organizations, governments, civil society, academia, and the private sector. Jointly organized by the United Nations Office for the Coordination of Humanitarian Affairs (OCHA) and the Swiss Agency for Development and Cooperation, HNPW provides an opportunity for professionals working in the sector to exchange experience, discuss new concepts, introduce new tools and ideas, connect, and collaborate in finding solutions to common challenges in crisis preparedness and response.

The in-person portion of HNPW 2024 will take place from 6 – 10 May at the International Conference Centre in Geneva (CICG). There is also a 'remote week' with virtual sessions scheduled from 29 April – 3 May.

More than 1,000 participants are expected to attend the 300+ sessions organized by more than 60 humanitarian networks and partnerships. Most sessions are open to the public, though advance registration is required. View the full list of sessions and register for individual sessions of interest here.

The Power of Trust: Sustainable Partnerships with Local Businesses for More Effective Crisis Response

Join us for a compelling high-level panel discussion hosted by the OCHA-UNDP <u>Connecting Business</u> <u>initiative</u> (CBi) focusing on the critical role of trust-building between the public and private sectors in disaster management. Distinguished panellists from diverse geographical backgrounds and contexts will draw upon their experiences in recent and ongoing emergencies to provide valuable insights.

Through A Localization Lens: Supply Chain Resilience Practices and Lessons Learned Tuesday, 30 April | 08:00 – 9:30 CEST | remote only

Organized by the Global Logistics Cluster. The session will be presented as connected talks from respective agencies, including representatives of National Disaster Management Offices, United Nations agencies, International NGOs, International Red Cross/Red Crescent, and more, who have been leading or engaged in locally led humanitarian supply chain and logistics preparedness and response initiatives in various parts of the world. Local Procurement: A Panel on Emerging Policy

Less than one percent of humanitarian funding is targeted to anticipatory action, despite evidence demonstrating that we can predict, with some certainty, at least two-thirds of crises before they strike. In this session, the H2H Network will delve into their partnership with USAID's Bureau of Humanitarian Assistance on their accelerator program that aims to support members in developing new tools, products, and services to enhance anticipatory action.
