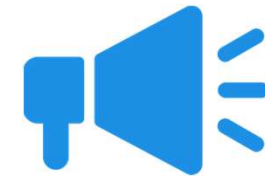

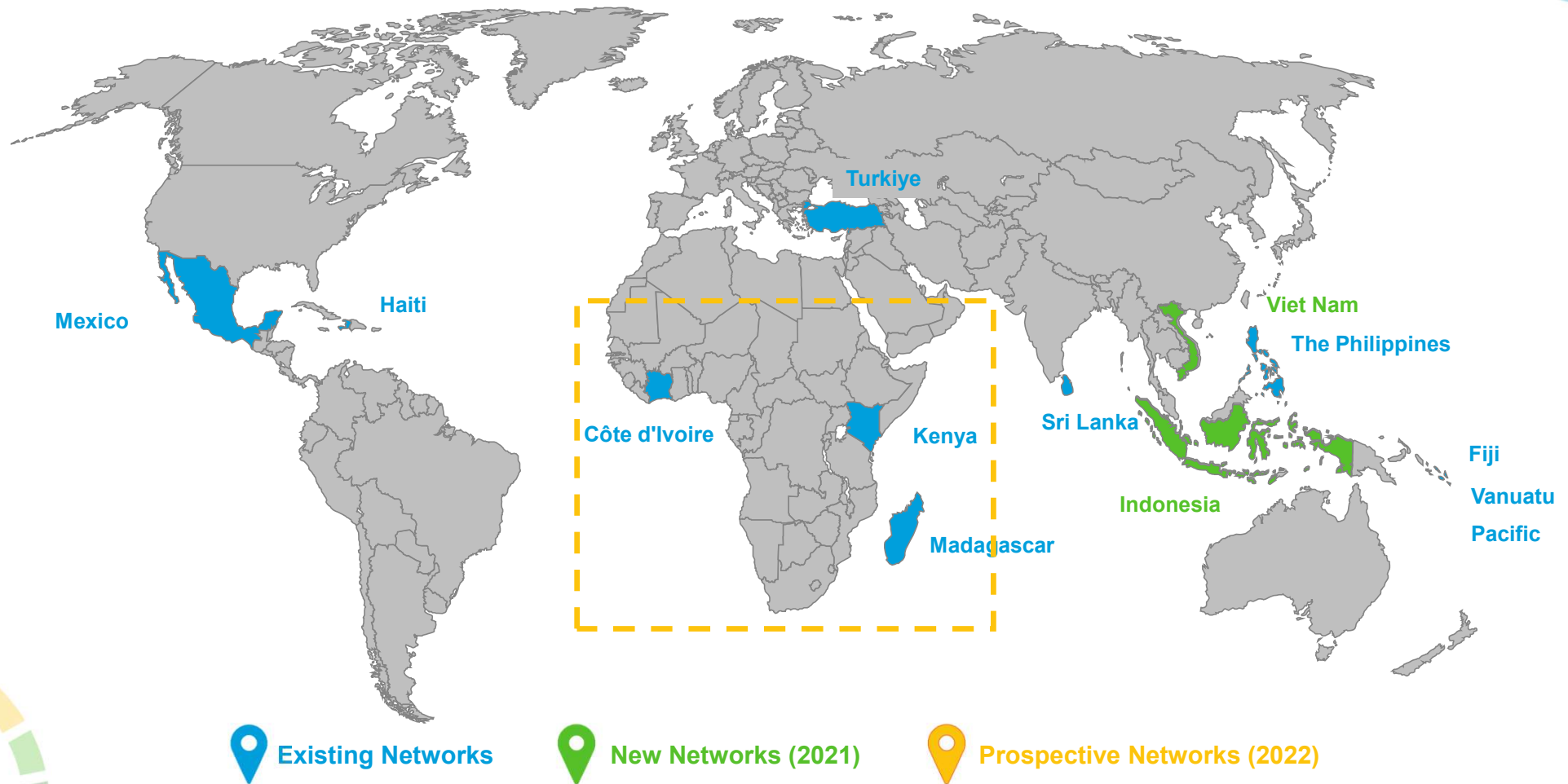

## Project Components

---

### Landscape Assessment

- **Map** existing private sector networks/ initiatives related to disaster preparedness and response, and recovery
- **Identify** entry points and opportunities for CBI engagement
- **Understand and assess** current initiatives, good practices, as well as challenges and gaps when it comes to private sector engagement by humanitarian actors

### Outreach Activities

- **Engage** through virtual awareness workshops for private sector networks, government, UN entities and other humanitarian partners in the region

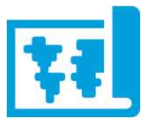

20 countries included in the preliminary scoping for Sub-Saharan Africa



### Key informant interviews (remote)

Interviews with focal points from OCHA, UNDP, the UN RCO, and UNDRR



### Desk research and literature review

Desk review included regional and national DRR/DRM frameworks

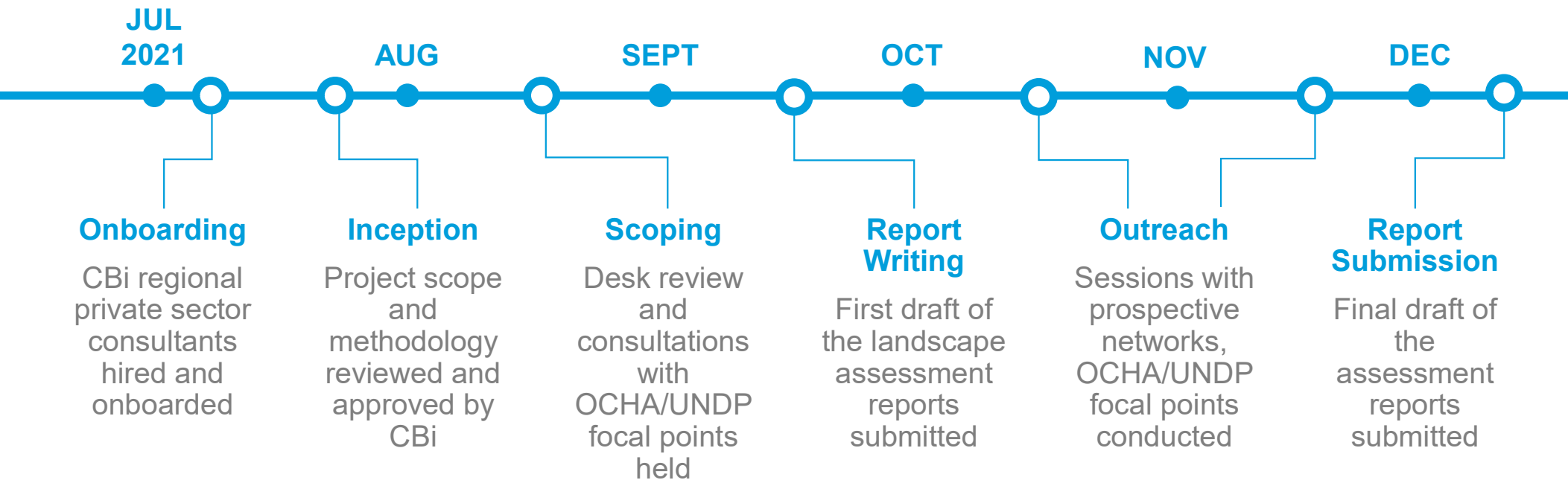


### Outreach sessions

Presented the preliminary findings to prospective countries/networks

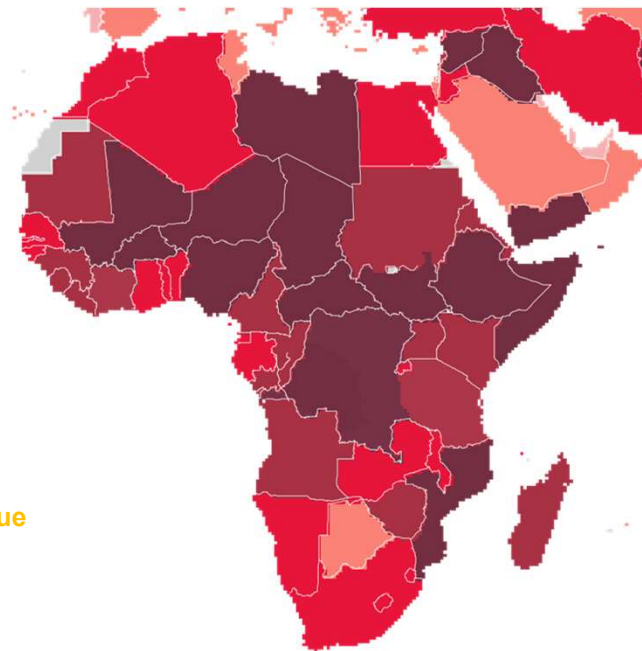
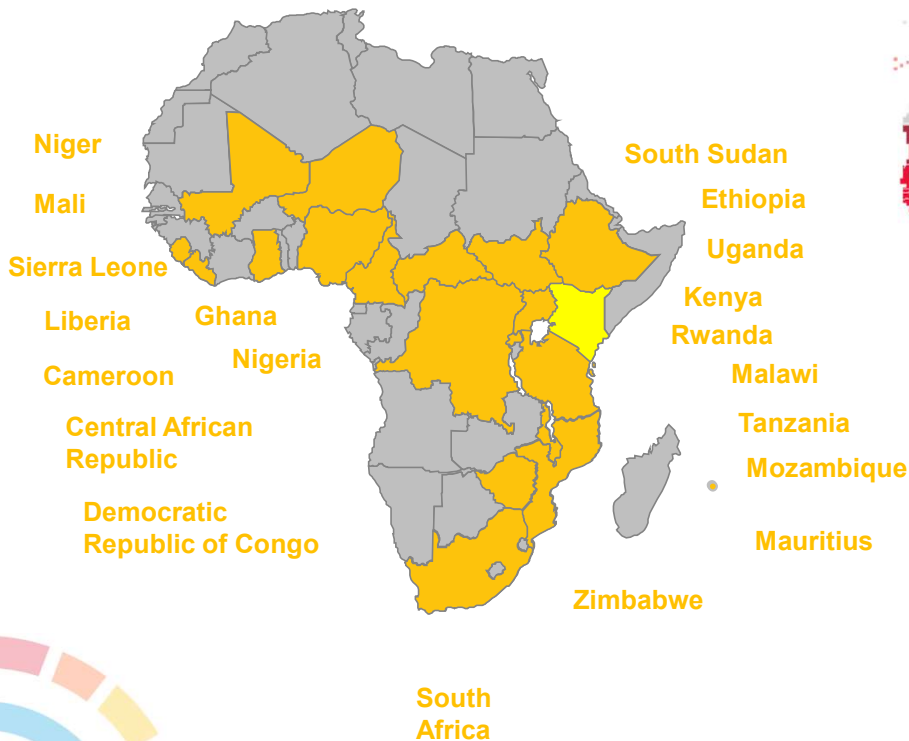

## Country Prioritization

### Criteria

- Disaster Profile: INFORM Risk Index
- Available Humanitarian Response Plan based on the OCHA Global Humanitarian Overview
- Presence of multiple business networks
- Consultations with OCHA and UNDP focal points (regional and country-level coordinators)

### Prospective Countries

- Four (4) prospective countries in Sub-Saharan Africa
- Reviewed CBI's current engagement with Kenya

## Network Characterization



### Knowledge Management

Identify, filter, and share information and knowledge; stimulate learning



### Amplification and Advocacy

Extending the reach and influence of initiatives



### Convening

Bridging and stimulating discourse, collective learning and action among different actors



### Resource Mobilization

Increasing the capacity and effectiveness of members



### DRR/DRM Engagement

Involvement in disaster prevention & mitigation, preparedness, response, and/or recovery

Sudanese Union of Chambers of Commerce (SUCC)	●	●	○	○					There were few references on humanitarian or DRR/M related activities done by and/or with the two business associations. The Small Industry and Handicrafts Chamber (with the SBEF) has been mentioned in the 2021 Sudan Rapid Post Disaster Needs and Recovery Assessment for the 2020 floods but no mention of concrete activities. The landscape assessment included the two business associations and Sudan as a prospective CBI country given the potential entry-point of the private sector based on lessons learned from the 2020 floods. Sudan is also a priority country of OCHA.

# FINDINGS

## Challenges in Sub-Saharan Africa

---



### Private sector capacity

Establishing CBI networks can be considered as demanding since 80% of the private sector in Africa are SMEs and many of these SMEs are from the informal sector.



### Increasing complexity of risks

With increasing humanitarian needs, fragility and exposure to weather extremes, private sector's capacity in the priority countries are also affected.



### Defining private sector engagement

There is a need to specify the engagement mechanisms and concrete value / benefits to private sector networks in becoming CBI networks and working with the UN.

# FINDINGS

## Private Sector Opportunities in Sub-Saharan Africa



### Build institutional capacity

Align with existing initiatives on building institutional DRR/M capacity and include / lobby for private sector involvement



### Explore innovative models with business networks

Consider exploring different engagement approaches (e.g., platform model, ecosystem approach) to support private sector capacity



### Regional network hub approach

Supporting multiple countries through sub-regional country hubs such as Kenya, Nigeria and even South Africa



### CBi-Global Compact partnership

Leverage existing CBi-Global Compact partnership to cross-fertilize DRR/M engagement with sustainable development agendas



### Cross-sectoral DRR/M approaches

Explore how private sector sees itself being involved and assess integration of humanitarian engagement in climate resilience, fragility and even supply chain resilience

## Entry-points for engagement in Sub-Saharan Africa

---



### Capacity-building

Potential activities can include DRR/DRM awareness-raising workshops, business continuity planning and introduction to the humanitarian system



### Advocacy

Promoting the importance of private sector engagement in disasters caused by natural hazards and in humanitarian crises



### Direct Engagement

Mapping of private sector resources and capabilities
