







## Businesses on the frontlines of humanitarian response: Lessons learned from Türkiye and beyond

#### **OVERVIEW**

There can no longer be any doubt that the private sector plays a critical role in disaster preparedness, humanitarian response, and early recovery. Businesses of every size are deploying their resources and expertise to support humanitarian response and improve the lives of families and children from Türkiye to Ukraine, the Horn of Africa, Asia and the Pacific, and beyond.

As governments around the world confront the challenges of more frequent and severe climate-driven disasters, conflict and forced displacement, and the lingering economic effects of the pandemic, it is clear that all stakeholders in society – including the private sector – must work together.

Investing in local businesses as partners in disaster risk management contributes to building community resilience while strengthening local capacity, ownership, and leadership. Engaging local businesses as partners in humanitarian preparedness, response and recovery can also help make aid more effective and efficient and ensures that emergency relief can contribute to long-term economic development.

Ms. Paola Albrito
Director, United Nations Office for Disaster Risk Reduction (UNDRR)

Ms. Paola Albrito was appointed as the Director of UNDRR in October 2022 and comes with extensive experience in supporting disaster resilience and sustainable development policies and instruments in Africa, Europe and Central Asia. Her broad expertise includes the development of policy guidance, cross-government strategy development, and high-level advocacy.

Edem Wosornu leads OCHA's Response Support Branch, which is responsible for strengthening national and international disaster response through specialized services, including the UN Disaster Assessment and Coordination mechanism, the International Network of Search and Rescue Advisory Group, and the Humanitarian Civil-Military Coordination Service.

The Branch also fosters strong operational partnerships with stakeholders, including the private sector through OCHA/UNDP's Connecting Business Initiative; and provides expertise to address the environmental dimensions of humanitarian emergencies through the UNEP/OCHA Joint Unit.

Kareem has over a decade of experience with the UN. From 2013–2016, Kareem served as a Programme Manager for UNOPS in Iraq, overseeing a portfolio of more than \$25 million in law reform and emergency humanitarian relief projects. From 2016-2018, Kareem served as Technology Partnerships Adviser to the Director of OCHA's Corporate Programmes Division, managing relationships with Google, Microsoft, Facebook, and dozens of other technology companies. From 2018-2021, Kareem was Partnerships Manager for OCHA's Centre for Humanitarian Data, where he was responsible for identifying, assessing and securing strategic partnerships with governments, foundations, and the private sector.

Prior to joining the UN, Kareem worked as a Legal Advisor at the International Center for Not-for-Profit Law, specializing in freedom of association in the Arab world. Kareem holds a Juris Doctor and a Master's in International Affairs from the George Washington University in Washington, DC.
